METHOD(S) USED:

1. The submitted marble was divided into two portions by marker and weighed before test.
2. One portion was then immersed into the submitted "Tang's Polystrip Floor Finish Stripper and Heavy Duty Cleaner" of 1:10 in water at ambient temperature for 20 seconds.
3. After 20 seconds, the marble sample was rinsed with running tap water for 1 minute and air-dried.
4. Difference in weight, general appearance including shininess, any color change, blistering, peeling off of surface.

TEST RESULT(S):

SUMMARY:

Based on the test results, the submitted "Tang's Polystrip Floor Finish Stripper and Heavy Duty Cleaner" when diluted to 1:10 in water with a contact time of 20 second at ambient temperature caused no effect to the submitted marble.
